**WHEREAS**, widening NC Highway 55 would enhance the safety of travel for vehicles, bicyclists, and pedestrians utilizing this section of roadway.

**THEREFORE, BE IT RESOLVED** that the Pamlico County Board of Commissioners hereby deems it in the best interest of the county and its citizens to support the widening of NC Highway 55 from Bayboro, NC to Oriental, NC.

**BE IT FURTHER RESOLVED**, as part of the project, it is requested that NC DOT relocate at its own cost any water utility lines that parallel NC Highway 55 such that the pavement edge is at least 5 feet from said waterlines.

Hi Mr. Buck,

I'm writing to let you and the County know that we have funds to upgrade NC 55. The description of the work is below and the funds are coming out of a new funding source that the General Assembly created in the budget called High Impact/Low Cost Projects. The idea is to fund projects that have been identified as a need by the RPO but don't score well in the scoring process (SPOT). One caveat for the funding is that the County Commissioners need to pass a resolution of support for the project if the cost is over \$250K, which this is. Do you think the Commissioners will support the project? If so, do you think it is possible to get a resolution early in the new year since we want to let it to contract in the Spring?

If you have any questions please let me know. Also, do I need to attend the meeting and present the project?

### NC-55 in Pamlico County

We will be performing symmetrical widening of two (2) feet on both sides of NC-55 from the End of C&G near NC-304 in Bayboro to the Beginning of the C&G in Oriental. We will not be performing any widening work within the C&G sections of NC-55 within these limits.

We will be performing a Milling and Filling operation within C&G sections and will be placing 2 inches of new asphalt within those sections.

We will be placing 2 inches of asphalt over the existing asphalt and widened sections from Bayboro to the Oriental Bridge. Total Length of Resurfacing 10.62 Miles.
