Dear Mr. Taft:

I am writing to share with you the appreciation we have for your assistance and of the District II staff, particularly Mr. Preston Hunter, Mr Steve Hamilton and Ms. Barbara Frizzell. After asking for a review of our request to lower the speed limit within the town limit of Oriental on Highway 55, you initiated action on our behalf. Thereafter, we were contacted by Mr. Hunter and others of the District II staff and subsequently they determined it was appropriate to lower the speed limit as we had requested and set things into motion to make that happen. Shortly after the Town received notice the speed limit would be lowered, Hurricane Florence arrived and visited devastation on not only our town but also many others in Eastern North Carolina. Knowing NCDOT was doing its part to help all of us recover from the storm, we expected our request would be delayed until operations returned to normal.

In late November, Martin Barrow, a Town Planning Board member, contacted the Division II office on my behalf and spoke with Ms. Frizzell. Ms. Frizzell made several inquiries and directed Mr. Barrow to Mr. Steve Hamilton to discuss the progress on our request. Within a week of Mr. Barrow's conversation, Mr. Hamilton contacted the sign unit and had the changes implemented. Subsequent to the initial signage

change, Mr. Barrow contacted Mr. Hamilton regarding some further refinements, which were carried out straightaway.

Please accept the Town's appreciation for the professional response and execution the District II staff provided in honoring our request. We are hopeful these changes will result in a safer highway lowering the likelihood of vehicular accidents and personal injury. The Town looks forward to continuing our partnership with NCDOT to make Oriental a safer place to live and visit.
