- 7. Staff Bonus Costs and request for direction/ Police Vacancy discussion (Tab 5) Approved at last meeting at \$10,377.76. Including FICA and Orbit, the cost is \$11,331.75. - **11.** Unexpected income from FEMA: (Tab 8) Approval of the overage request was sent with indication of the receipt of \$106,644.12 within 45 days. We requested the overage of the South Ave estimated at \$323,306, and completed for \$216,661. Described equipment needs of replacement of Police vehicle and dump truck.
