Subject: 2021 Powell Bill Allocation – System Street changes within the Corporate Limits

Dear Mayor Belangia,

In preparation for allocation of the 2021 Powell Bill funds, this office has been requested to contact all municipalities currently receiving these funds regarding system street changes within their corporate limits. This applies to additions to or deletions from the State Highway System due to city limit changes, annexation, route changes, or any other reason.

If you have changes involving additions to, or deletions from, the State Highway System, please notify me at your earliest convenience, so I can begin to assemble the necessary package information. I will need an approved resolution from the municipality's governing body approving the changes and a map marked in red showing the exact location of the proposed street to be added or deleted.

All changes must be officially approved by the Board of Transportation before a municipality can claim said streets for 2021 Powell Bill funding. **To meet this deadline, you will need to get the completed and properly executed paperwork into this office by April 26, 2021.**

As a reminder, for a municipality to receive Powell Bill funding for a street, the street must be within the corporate limits and "... maintained by a municipality and open to use by the general public and having an average width of not less than 16 feet." (NCGS 136-41.1)

RESOLUTION TO CORRECT ORIENTAL POWELL BILL MAP

THAT WHEREAS, The Town Manager reviews and corrects the Powell Map according to annexations, closures, and other adjustments to the Official Powell Bill Map annually; and

WHEREAS, the Town of Oriental has not made any of those amendments, but has, however, discovered inconsistencies in the existing map; and

WHEREAS, the corrections are attached in "Map included as directed" to NCDOT for adjustments to the official map; and

WHEREAS, the Eastern Carolina Council of Governments is creating the corrected map for the Town as required, but the corrections have been noted and shown to the Town Board in a marked up version at their monthly meeting on April 6, 2021; and

WHEREAS, those changes include:

- Shorten South Ave by .02mi;
- Delete Ave A aka Smith Point Rd;
- Change .02 mi of South Ave to PRIVATE RD;
- Add Madison Ave at .38mi

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF ORIENTAL:

That the Mayor and Board of Commissioners of the Town of Oriental agree with the proposed changes and authorize the Manager to submit the required adjustments and file those with NCDOT in advance of the Powell Bill allocation for the 2021-2022 Fiscal Year.
