5. **Proposed GMO Change (add tent camping) 2022-286(Public Hearing) (Tab3) :** *The Planning Board addressed the creation of tent-only camping as an amendment to the RV Ordinance (Section 135) so that it includes both, rather than create a separate Ordinance. As it had not been previously addressed and there were inquiries, the Planning Board felt the need to include potential tent campgrounds in the GMO.*
6. **Capital Reserve Ordinance discussion: (Tab 4)** *Following enactment of the 22-23 Budget, we still need to enact the Capital Reserve Ordinances required as all that had been reserved has been used. The Board may discussed how much/what is being set aside for which pieces of equipment/vehicles and length of reserve.*
