Good afternoon Ann and Diane,

It was nice speaking with you this morning, Ann. To summarize, Senate Bill 508 became law on May 15th and it is now Session Law (S.L.) 2024-1. The new law reduces the DWI administrative fee from 3% to 1.5% for the S.L. 2023-134 direct appropriations. This means the Town of Oriental's direct appropriation available for projects increases from \$5,335,000 to \$5,417,500. To date, we've received a Request for Funding (RFF) form from The Town of Oriental requesting \$5,335,000 and we've issued a Letter of Intent to Fund for the "Water Systems Improvements" project (Project #: SRP-D-134-0031).

As a result of the S.L. 2024-1 administrative fee changes, the Division plans to issue a funding offer and add the extra 1.5% amount (\$82,000) to the amount requested in the RFF (\$5,335,000), resulting in a Total Offered Amount of \$5,417,500.

David Smith is our new contact for the S.L. 2023-134 direct appropriations and he'll be drafting the funding offers for these projects. I've included David on this communication.

David - Diane Miller is the Town Manager for the Town of Oriental and Ann White is with the North Carolina League of Municipalities. Ann called on the Town's behalf stating that the Town is ready to proceed with their project and is requesting their funding offer as soon as practical.
