AN ORDINANCE TO AMEND THE ORIENTAL CODE OF GENERAL ORDINANCES.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF ORIENTAL.

Section 1. That the Oriental Code of General Ordinances, Chapter R, Section 1. Composition, be amended as follows:

The HWAC shall be composed of five (5) seven (7) regular members (either full-time town residents or non-resident Oriental business owners or employees associated with public or commercial water-related goods and services). At least three members must be full-time residents of the Town of Oriental. Up to two (2) members may be non-residents of the Town, but must reside in Pamlico County. The HWAC will also be served by two commissioners: one Liaison and a second Co-liaison, appointed by the Board. The Liaison may vote only to break a tie, or, if the Liaison is not present, the Co-liaison may vote to break a tie. It is highly recommended that at least one member of the HWAC also be a member of the Parks and Recreation Advisory Committee.

Section 2. This Ordinance shall be effective July 1, 2022.
