Good Morning,

There was a question the attorney was researching. The Charter is a State local bill. Local Bills trump statute- for example- you cannot drive golf carts on state roads (or any roads really) unless you have a state local bill allowing it. The Charter is a State Local bill. Charter says you need the Mayor and a majority of Commissioners to call a meeting. Statute says The mayor, the mayor pro tempore, or any two members of the council may at any time call a special council meeting by signing a written notice stating the time and place of the meeting and the subjects to be considered.

His response was positive- the Charter does trump the statute. So- the Mayor and a majority of Commissioners are required to call a Special Meeting. Previously, I had been guiding you according to statute, and apparently, that is incorrect. (See attached) This came up because I asked him to confirm the quorum numbers. According to the charter, the quorum is determined to include the Mayor. Quorum is the Mayor PLUS 3

Commissioners. If you would like to call a special meeting, Lisa has the draft of the document that needs to be signed by the Mayor plus 3 to call a Special Meeting.

There was also a question about how the 48 hours works. Remember when we did the "no exotic animals" Ordinance? That started late on a Friday, the attorney walked me through the Ordinance proposal, we met first thing Monday morning- so it is TIME, not BUSINESS DAYS. I am fairly confident in that because Scott was so very integral to that process. Scott, please correct me, if I am wrong.

As this seems to be very contentious, I am simply making sure we are following the law.

It seems several of you have spoken to the attorney, and his main point is that choosing a method needs to be a very thoughtful action, perhaps best left until after elections, leaving the vacancy open until the election. Something to consider. However, if you do choose to move forward with a meeting to discuss the options and a tie breaking method.

Last I was able to follow an email trail (which is much more difficult on an iPhone, so I'm at the office), you had postponed the meeting with the Sheriff to a later date. Is that true? Just trying to keep it all straight.

I'm in and out and intermittently reachable by phone. I'll try to keep my phone near.
